RESOLUTION SUBJECT: FEES FOR FOOD ESTABLISHMENT PERMITS


WHEREAS the Board of Health of Snohomish Health District is empowered pursuant to RCW 70.05.060 to establish fee schedules for licenses, permits or for such other services as are authorized by law, and

WHEREAS the 2006 budget necessitates amending the 2006/2007 Environmental Health Fee Schedule, and

WHEREAS the Board of Health of Snohomish Health District has reviewed fees being charged for food establishment permits, and has determined that an amendment to the fee schedule is appropriate and warranted to cover the cost of needed new positions in the Food Program as approved by the Board in adoption of the 2006 Budget, and further, has determined that the amended schedule will not result in fees collected in excess of the cost of providing the services entailed,



SUBJECT: Amended 2006/07 Food Establishment Permit Fee Schedule

At the November 15th Board of Health Meeting, Action Item 9.a. was approved that includes increasing food establishment fees pursuant to Option 3 as outlined in the Robert Pekich memo dated November 9, 2005, and the addition of two new full-time Environmental Health Specialist positions to start July 1, 2006.

The attached amends the 2006/2007 EH fee schedule and reflects a 25% fee increase for risk category B and C food establishment permits. The intent of the fee increase is to cover the costs of the two new positions in the Food Program in 2007.
