RESOLUTION SUBJECT: REVISION OF SNOHOMISH HEALTH DISTRICT SANITARY CODE CHAPTER 10.1 FOOD SERVICE REGULATION, CHAPTER 246-215 WAC

WHEREAS the Board of Health of the Snohomish Health District serves to promote the public health of the residents of Snohomish County, and under the provisions of RCW 70.05.060, maintains supervision over matters pertaining to the preservation of the life and health of the people within its jurisdiction, and

WHEREAS THE Board of Health has incorporated into the Sanitary Code of Snohomish Health District certain public health statutes of the state and rules promulgated by the State Board of Health and Secretary of Health, to provide for the control and prevention of any dangerous, contagious or infectious disease within its jurisdiction, and provide for the prevention, control and abatement of nuisances detrimental to the public health, and

WHEREAS the Snohomish Health District incorporated within Chapter 10 of the Sanitary Code, Food Service Regulation, Chapter 246-215 WAC, and

WHEREAS the Washington State legislature has required that revisions of the Food Service Regulation be considerate of the most recent version of the United States food and drug administration's food code, and

WHEREAS the Washington State Board of Health has adopted on October 10, 2012 the revised language of the Food Service Regulation, Chapter 246-215 WAC,

NOW THEREFORE the Board of Health of Snohomish Health District hereby takes the following actions to become effective May 1, 2013:

- (1) Rescinds Chapter 10.2.1 of the Sanitary Code of Snohomish Health District, "Food Service Personnel Handwashing Requirements."
- (2) Rescinds Chapter 10.2.2 of the Sanitary Code of Snohomish Health District, "Enforcement Procedures, Hold Orders, Examination, and Examination and Condemnation of Food (Procedures for implementing WAC 246-215-240, 4/2/86, & forms)."
- (3) Rescinds Chapter 10.3 of the Sanitary Code of Snohomish Health District, "Food Establishment Construction Plan Guidelines, in addition to WAC 246-215-150."
- (4) Rescinds Chapter 10.3.1 of the Sanitary Code of Snohomish Health District, "Food Establishment Upgrading If Ownership or Operation Changes."
- (5) Rescinds Chapter 10.5.1 of the Sanitary Code of Snohomish Health District, "Temporary Food Service Permit for Low Risk Food Items."
- (6) Rescinds Chapter 10.9 of the Sanitary Code of Snohomish Health District, "Athletic Field Concession Stands."

- (7) Rescinds Chapter 10.10 of the Sanitary Code of Snohomish Health District, "Guidelines for Food Catering Operations."
- (8) Adopts WAC 246-215, Food Service, adopted October 10, 2012 by the Washington State Board of Health, as Chapter 10.1 of the Snohomish Health District Sanitary Code, "Food Service" to be administered and enforced by the Snohomish Health District.
- (9) Renumbers Chapter 10.7 of the Sanitary Code of Snohomish Health District, "Food Service Manager Training and Certification" as Chapter 10.3 of the Sanitary Code of Snohomish Health District, "Food Service Manager Training and Certification."
- (10) Renumbers Chapter 10.7.1 of the Sanitary Code of Snohomish Health District, "Recertification Training of Restaurant Managers and Operators" as Chapter 10.3.1 of the Sanitary Code of Snohomish Health District, "Recertification Training of Restaurant Managers and Operators."
