RESOLUTION SUBJECT: APPROVAL OF THE CALENDAR FOR THE 2020 BUDGET
AMENDMENT AND 2021 BUDGET

WHEREAS, the Snohomish Health District budget reflects revenues and expenditures that support public health services throughout Snohomish County; and

WHEREAS, the Board of Health annually adopts its yearly budget in December of the previous year; and

WHEREAS, Board members work with staff during the year to finalize any necessary amendment to the current year's budget and the coming year's budget; and

WHEREAS, by Res. 18-27 the Board directed staff to develop a budget calendar process that can be applied and used in amending the 2020 budget and developing the 2021 budget and budgets thereafter; and

WHEREAS, the draft calendar proposed by staff was provided to the Administration Committee and the Executive Committee at their May meetings for feedback.

NOW, THEREFORE, the Board of Health approves the proposed calendar for the 2020 amended budget and 2021 budget as shown in Attachment A of this resolution.
