RESOLUTION OF THE BOARD OF HEALTH





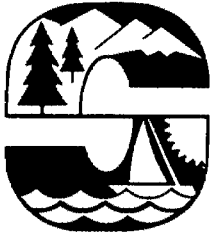
