Minutes

Moved by Mr. Culmback, seconded by Mr. McCollum and carried that minutes of last meeting as previously circulated to members be approved.

Auditing Chairman Kraetz appointed Messrs. Culmback and Stocker as the Committee. Auditing Committee.

Emander Dump Doctor Knipe reported that a meeting had been held attended by the County Commissioners, Mr. Jefferson of the Prosecutor's Office, Health Department, and Mr. Bilderback, at which time it was agreed that the contract between the County and Mr. Bilderback be dissolved effective January 1, 1960. A meeting has been scheduled for December 9 of all interested parties to discuss re-wording of the present contract. There would be subsequent meetings held this month for the purpose of issuance of call for bids according to revised contract.

Social Assistance Miss Kyle reported that in accordance with Mr. Johnson's request of last meeting, she had contacted Mrs. Muckey of the Everett office of the State Department of Social Assistance. Mrs. Muckey stated that she felt her remarks had possibly been misunderstood by Mr. Johnson and that she did not wish to appear before the Board of Health.

Rodent Control Mr. Stockton reported that, as requested at the last meeting, the and members of his staff had met with Mr. Johnson. It was agreed that the Port Commission would be requested to cooperate in a program of rodent control.

Notice of Election

The Executive Secretary drew the Board's attention to the Charter requirements whereby election of officers and appointment of 7th member, District Health Officer and Board Attorney would properly be held at the first meeting in January.

<u>Board of Health</u> <u>Authority</u> The Executive Secretary requested clarification of the Board's policy and intent as to its' authority for authorizing payment of accounts by the County Auditor and Treasurer. Mr. Ingram stated that in his opinion the Board of Health had full authority and that the County Treasurer and Auditor were in effect acting on behalf of the Board of Health and not the County whenever they performed statutory duties as outlined in the Public Health Law. In summary he stated it was mandatory that these County officers so act on instructions of the Board of Health.

<u>Rules and</u> <u>Regulations</u> Health Officer stated that a review of previous City and County Ordinances, Rules and Regulations would be undertaken early in the new year in that there were various discrepancies.

<u>New Staff</u> Doctor Knipe requested approval of his appointment of Miss Shirley Forsgren, new clerk in the office, as follows:
