Gentlemen and Mrs. Simpson:

Yesterday Mr. Johnson asked me to prepare a resolution for budgetary transfer to provide travel expenses for a prospective applicant. I prepared this resolution at his request, and it is in the hands of Dr. Beare.

Thereafter Mr. Kraetz discussed the legality of such disbursement and requested that I examine budgetary procedures in this regard.

I conclude that the Health District as a municipal corporation does not have authority to pay the travel expenses of a prospective employee; and while the transfer from Health Officer's salary to maintenance and operation under travel expense is legal, any disbursement to the applicant would not be valid.

However, in the event the Board desires to send a Board employee to interview the applicant, this would be a proper travel expense and could be paid.
