# Health Board Discusses Salaries in Closed Meet

Members of the Snohomish County Health District Board met for some two hours yesterday in a session closed to the public and news media to discuss possible salary and assessment increases for the district.

Health department staff members who had come prepared to deliver reports on their work were asked to leave so the board could discuss salaries. After waiting for some time for the closed session to end, staff members left without delivering their reports.

Health District Administrator Dave Stockton said

this morning that the board members wanted a closed session so they could prepare for today's opening salary negotiations with representatives of the nurses', clerical workers' and sanitation workers' organizations. The board members came to an agreement on the percentage of salary increase which they would concede to the employes. The percentage figure was not disclosed.

The board also discussed possible tax assessment increases for county residents to support salary increases and other expenses. The current assessment is 50 cents per person in the county, including cities and unincorporated areas.

Stockton said the board considered increasing the assessment to 75 cents or \$1, but no formal decision was made.

In open session, the board discussed proposed participation in a new program for alcoholics. A decision will be made at a later meeting on whether the district should offer partial financial support of the program beginning in January, said Dr. Clifford Anderson, health officer.
