Report

Health OfficerDr. Darrough gave an activity report of his activities for the month of April. He reported that there had been one case of Diphtheria in the west Marysville area affecting a 5yr. old in which a fatality was noted. The Health District is very busy giving immunizations to the people in the Marysville area.

Supervisor Reports

Mr. Stockton reported that he had attended a recent meeting on Accounting Procedures with Washington State Department of Health. He outlined the advantages of combining individual line items into aggregate sums under certain sub-headings in the health department budget. The Board approved his request to use this new format for the 1971 budget.

Mr. Stockton reported that the Snohomish County Comprehensive Health Planning Council is now holding regular meetings and starting to consider specific proposals. He stated that letters have been received regarding establishing a stroke center in Everett and that a representative from the Regional Medical Program has been invited to the next meeting for further discussion.

Dr. Luke, Veterinarian, gave his division's activity report. He reported that the Veterinarian Association had a good turn out on the Rabies Clinic held in Ever.

Mr. Moser, Director of the Environmental Health Division distributed copies of his division's activity report.

Mrs. Chandler, Director of Nursing, introduced Mrs. Pauline Kliewer as our new Supervisor of Nursing. Her salary will be \$821.00 per month. She reported that the demands for nursing service are increasing each month. The South County clinic continues to be very busy every Wednesday afternoon.
