Call to Order

Roll Call

Approval of Agenda Contents and Order

It was moved by Mr. Terry Ryan and seconded by Mr. Liam Olsen to approve the agenda contents and order. The motion passed unanimously.

Approval of Minutes

Special Business

Mr. Jeff Ketchel noted that Board member Rasmussen tendered his resignation from the Board. The resolution honoring Mr. Rasmussen, plus resolutions honoring PHAC members Brant Wood and Fred Worthen, were available to the Board but were not read aloud.

Consent

- d. Authorize the Administrator to sign the grant agreement with the Department of Ecology for activities related to solid waste

Mr. Ketchel was elected last week as vice chair of the Snohomish County Health Leadership Coalition. Dr. Beatty and other staff are at the WSALPHO conference this week. Mr. Ketchel attended a training on critical conversations last week. Last week the Health Care Authority notified the Health District that the Early Intervention Program (EIP) \$134,000 grant may be cut on Oct. 1.
